In G.O. No. 580/ Social Welfare, dated 15.7.76 orders were issued to close down the two Government Notified Tribes Boarding Homes, at Manguneri and Srivaikuntam of Tirunelveli District and to open 2 new hostels at Manapad and Idinthakarai of Tirunelveli District with effect from the academic year 1976-77. Without involving any extra expenditure. In Government Memorandum 63227/BC.III/76-2, Social Welfare, dated 13.11.76, the action of the Collector of Tirunelveli District in having started two new Backward Classes Hostels at Manapad and Idinthakarai in lieu of the two Notified Tribes Boarding Homes closed at Manguneri and Srivaikuntam was ratified. The Director of Backward Classes has stated that the two Backward Classes Boys Hostels at Manapad and Idinthakarai have started functioning with effect from 3.9.76 and 9.9.76 respectively. He has requested Government's sanction for the staff and other expenditure for the above two hostels from the dates of their opening. The Government accept the proposal of the Director of Backward Classes.

2. Sanction is accorded to the employment of the staff and to incur other items of expenditure as detailed in the Annexure to this order on the following two hostels with effect from the dates noted against them till the need therefore ceases subject to the condition that the maximum number of boarders for these hostels is fixed on a regular basis and maintained at that level.

- (1) Government Backward Classes Boys Hostel, Manapadi

3. The staff excluding cooks and watchmen-cum-servant of the hostels are eligible to draw dearness Allowance, House Rent Allowance and other allowances admissible under the rules in force from time to time.

4. The expenditure should be debited to "288, Social Security and Welfare - C. Welfare of Scheduled Castes, Scheduled Tribes and other Backward Classes - as Welfare of other Backward Classes-I. Non-plan-AD. Backward Classes Hostels" (D.P. Code 288C HEAD 0003).

In the G.O. second cited sanction was accorded to the employment of staff for the following two government Backward classes Boys Hostel in Tirunelveli District with effect from the dates noted against them:-

- (a) Govt. Backward classes Boys Hostel, Manapad .. 3.9.1976
(b) -do- , Idinthakarai .. 9.9.1976

The District Backward classes welfare Officer, Tirunelveli has now reported that, based on the orders issued in the G.O. first cited, in which orders were issued to close down the two government Denotified Tribes boarding Homes at Nainguneri and Srivaikuntam of Tirunelveli District and to open ~~two~~ two new Backward classes Boys Hostels at Manapad and Idinthakarai in the same district from the academic year 1976-77, to make preliminary arrangements like collection of applications, purchase of vessels, furniture, selection of building etc. wardens were appointed to the above two Backward classes hostels and they joined duty on the following dates:

Manapad	..	5.8.1976
Idinthakarai	..	1.9.1976

As the pay of these two wardens could not be drawn prior to 3.9.76 and 9.9.76 respectively, the District Backward classes Welfare Officer, Tirunelveli has requested specific sanction of government for the employment of wardens from 5.8.1976 to 2.9.76 (Manapad) and from 1.9.76 to 8.9.76 (Idinthakarai). The Director of Backward classes has also recommended the request of the District Backward classes welfare Officer, Tirunelveli District.

2. The government accept the recommendation of the director of Backward classes and accord sanction for the employment of wardens in the following two Government Backward classes Boys Hostels in Tirunelveli District for the period mentioned against them:

- (a) Manapad .. from 5.8.1976 to 2.9.1976
(b) Idinthakarai .. from 1.9.1976 to 8.9.1976

3. The expenditure should be debited to "288. Social Security and welfare - c. Welfare of Scheduled Castes, Scheduled Tribes and other Backward classes - ae. welfare of other Backward classes - I. Non-plan - AD. Backward classes Hostels (D.P. Code 288C AEAD 0003).

4. The action of the district Backward Classes welfare Officer, Tirunelveli District in having appointed the two wardens of the above hostels during the period mentioned above, without prior sanction of Government is ratified.
