ORDER:

The Govt. sanction the opening of three new hostels for
Denotified Communities High School students during 1983-84.
The location of the hostels and the strength are as detailed
in the Annexure.

2. The Govt. also sanction employment of the staff for the
three new hostels sanctioned in para (1) above as detailed
in the Annexure to this order from the date of appointment
till the need therefor ceases, subject to the conditions
that the sanctioned strength in these hostels as referred to
in the annexure are scrupulously maintained.

3. The staff will be eligible to draw the usual allowance
admissible under the orders inforce.

4. Sanction is also accorded to the incurring of the
following items of expenditure.

5. The Government accept the recommendation of the Director of Backward Classes for the supply of dresses to the boarders in the three Denotified Communities Hostels proposed to be opened at the rate of Rs.30/- (Rupees thirty only) per pair of dresses to each inmate in the three hostels.

6. The expenditure in respect of opening of the three Denotified Communities hostels should be debited to "288.C.Welfare of Scheduled Castes, Scheduled Tribes and other Backward Classes Schemes in the Sixth Five year Plan.II.State Plan.JA Denotified Communities hostels. (D.P.Code No.288C. ADJM 0006)
