ORDER:

In the Government order first read above, the Government have sanctioned the opening of a Hostel for college girls at Kuzhithurai, Kanniyakumari District during 1973-74 with a sanctioned 39 boarders. It has been reported that only 39 boarders were admitted in the above hostel during 1973-74. As sufficient number of boarders have not come forward for admission in the above hostel, the District Welfare officer, Kanniyakumari has proposed that the strength of the above hostel may be reduced from 100 to 50 boarders and that another hostel for college girls may be opened at Agstheeswar- am with 50 boarders during 1974-75. The Director of Backward Classes has recommended the proposal.

2. In the Circumstances stated by the Director of Backward Classes, the Government direct that the sanctioned strength of the Government hostel for college girls, Kuzhithurai be reduced from 100 to 50 from the academic year 1974-75 onwards.

3. Sanction is accorded to the opening of a backward classes hostel for college girls at Agstheeswar- am, with a strength of 50 boarders from the academic year 1974-75.

4. Sanction is also accorded to the employment of the staff to the Government hostel for College Girls Agstheeswar- am as detailed in the annexure to this order for the period of one year from the date of appointment. Sanction is also accorded to the incurring of expenditure as detailed in the annexure.
